प्राधिकरणांचे अधिकार, कार्ये व कर्तव्ये.

६१. या अधिनियमाच्या अन्य कोणत्याही तरतुर्दीअन्वये निर्धारित करण्यात आले नसतील अशी विद्यापीठाच्या प्राधिकरणांची रचनां, त्यांचे अधिकार, कार्ये आणि कर्तव्ये ही परिनियमांद्वारे विहित करण्यात आल्याप्रमाणे असतील.

प्राधिकरणांच्या सदस्यांचा पटावधी

(१) पदिसद्ध सदस्याव्यतिरिक्त, अन्य सदस्य आपल्या स्वतःच्या सहीने राजीनामा देज शर्वज्य कुलपतीने नामनिर्देशित केलेली व्यक्ती, कुलपतीच्या नावे पत्र लिहून राजीनामा देज शकेल आणि अन्य कोणताही सदस्य कुलगुरूच्या नावे पत्र लिहून राजीनामा देज शकेल. कुलपतीने किंवा यथास्थिति, कुलगुरूने राजीनामा स्वोकारन्यान्य किंवा, राजीनाम्याच्या दिनांकापासून तीस दिवस पूर्ण झाल्यावर, यापैकी जे अगोदर घडेल तेव्हापासून सी व्यक्ती सदस्य असण्याचे बंद होईल.
- (२) कोणत्याही प्राधिकरणावर किंवा मंडळावर नामनिर्देशित केलेली, निबदून आलेली, नियुक्त केलेली किंवा स्वीकृत केलेली व्यक्ती, त्या प्राधिकरणाच्या किंवा मंडळाच्या पूर्वपरवानगीशिवाय लागोपाठच्या तीन बैठविका अनुपस्थित राहील तर, तिने आपले सदस्यत्व सोडले असल्याचे मानण्यात येईल आणि ती, ज्या अशा तिसन्या बैठकीस अनुपस्थित राहिली असेल त्या बैठकीच्या दिनांकाणासून ती सदस्य असण्याचे बंद होईल :

- (३) अन्यया तरतृद केलेले असेल त्यार्व्यतिरिक्त अन्य बावर्तात. बैठकीची गणपूर्ती, सर्वसाधारणपणे विद्यापत्य सदस्यांच्या एक तृतीयांश इतक्या संख्येने होईल. बैठकीची गणपूर्ती होत नसेल तर, अध्यक्ष त्याच दिवशी किया नंतरच्या दिनांकास विशिष्ट वेळेपयेंत बैठक स्थिगत करील आणि पुढे चालू ठेवलेल्या बैठकीच्या पुढील दिवशी गणपूर्तीची आवश्यकता असणार नाही.

- (५) अन्यथा तरतृद करण्यात आली असेल त्याव्यतिरिक्त इतर बावतीत, कार्यसृचीवरील सर्व बाबी, प्रथम, विषय विज्ञा प्रस्ताव यांवर उपस्थित असलेल्या सदस्यांच्या बहुमताने निर्णय घेण्यात येईल. अध्यक्षास मत देता येईल. समसमान मते पडतील त्याबावतीत, अध्यक्षास निर्णायक मत देता येईल. सचित्र हा सदस्य नसेल तर, त्यास विचारविमर्शात भाग घेण्याचा हक्क असेल, परंतु त्यास मतदानाचा हक्क असणार नाही.

- ७०. ORDINANCES PRESCRIBING DUTIES OF TEACHERS OF THE UNIVERSITY

O. 3613. - The names of persons recognised as University teachers whose services have been transferred from one college/institution to another, or who have been transferred from one post to another post in another department in the same college/institution or appointed as Head/Dean/Principal in the same College/Institution or in any other college/institution, shall remain on the list of teachers of the University for a period of six months, in which period no part of the University vacations shall be inclued, in order to allow a fresh application for recognition being considered.

(i) Teachers recognised for examinations by papers.

- O. 186. As a condition of his recognition, a post-graduate teacher shall do the teaching work assigned to him, and if he does not do so, his recognition will be withdrawn.
 - O. 187. (a) Post-graduate lectures and seminars shall be spread over the whole term. Ordinarily lectures or seminars shall be delivered or conducted by every teacher, once a week.
 - (b) As regards practicals for science students, each science teacher shall supervise practicals for 16 hours per week. A teacher supervising practicals for science students for 16 hours a week may be permitted to deliver not more than one lecture a fortnoght.
 - (c) For the purpose of equating the supervision of practicals in science subjects by teachers, 16 hours of supervision shall be equal to 2 lecture periods.
- O.188. Post-graduate teachers shall from themselves into a Committee, and meet before the end of second term of the academic year to draw up time-tables of Post-graduate lectures for the following year.
- O.189. The Chairman of each Committee of recognised teachers shall be selected from among the following in the order mentioned as under:-
 - First Member of the Board of University Teaching and Research in the subject, and if there be more than one, the senior among them.
 - Second Member of the Academic Council representing the subject, and if there be more than one, the senior among them.
 - Third If the recognized teachers in a subject do not include a person answering to any of the above descriptions, the teachers shall elect one of their members to be Chairman, annually when they meet to draw up a time-table for the following year.

Provided always that notwithstanding what is stated above where there is a University Department in the subject, the Head of the Department shall be the Chairman of the Committee of recognized teachers in the subject.

- O.190. Post-graduate lectures shall be delivered by teachers at the place or places with due regrad to -
 - (a) the convenience of the student registered in the subject;

and

- (b) the convenience of the teachers giving the lectures;
- (c) the facilities available in the shape of accommodation, library, transport,

- O.191. Post-graduate teachers desiring to make changes in the timing or places of their lectures or seminars shall communicate the same to the University, through the Chairman of the Committee of regcognized teachers in their subjects, and where the notice of such change is shorter than 2 days, they shall also communicate the same to the Head of the Insitution where the lecture or seminar is due to be held.
- O.192. The Chairman of the Committee of recognized teachers in the subject shall convene meetings of the committee for drawing up a time-table of post-graduate lectures in the subject, or for revising the same, if necessary.
- O.193. Post-graduate teachers shall keep attendance rolls of post-graduate students and submit the rolls to the University at the end of every term.
- O.194. The Chairman of the Committee of post-graduate teachers, or in his absence, the next senior member, shall at the end of each academic year, certify the attendance kept by students for the purpose of terms.
- O.195. The Chairman of the Committee of post-graduate teachers, or, in his absence, the next senior member, shall have power to condone deficiencies under:-
 - 5 percent of 2/3rds of total number of lectures delivered and seminars conducted in the subject during the term.

Or

5 percent of half the number of lectures in each paper during the term :

Or

5 percent of half the number of seminars in the subject during the term:

The question of condoning deficiencies not covered by this rule shall be placed before the Board of University Teaching and Research.

- O.196. A teacher shall not without the permission of the Board of University Teaching and Research for subjects in Faculties of Arts and Science, register under him more than 12 students at a time for the M.Sc. degree by Papers.
 - (ii) Teachers recognised for guiding for students for research degrees.
- O.197. As a condition of his recognition, a teacher recognised for guiding students for research degrees shall guide research students, and if he does not so, his recognition may be withdrawn.
- O.198. A teacher in a science subject shall not ordinarily be permitted to guide students at a place of research other than the one at which he is recognized as a teacher.
- O.199. A teacher recognized for guiding students for research degrees shall not, without the permission of the Board of University Teaching and Research concerned, take for guidance at a time more than 10 students, inclusive of students registered partly by research and partly by papers.
- O.200. A research student already registered and receiving guidance from his teacher shall be deemed, for the purpose of 0.199 to continue under the guidance of his teacher until he submits a synopsis of his thesis for a research degree.
- O.201. A teacher recognized for guiding research shall, as a condition of his recognition, serve an internal referee to examine the thesis of the students registered under him.
- O.202. Teachers recognised for guiding research shall, every three years or whenever required, submit reports of their work during the period.


